Alessandra Di Martino is Associate Professor in Comparative Public Law at the University of Rome *Sapienza*, School of Law. She was Researcher of the same subject from 2011 to 2018 (confirmed in 2014). In December 2013, she earned qualification as Associate Professor; in March 2018 she earned qualification as Full Professor. In November 2018 she also earned qualification as Associate Professor in Constitutional Law (relating to the ASN session of 2012). She holds a Degree in Law (hons., 2002) and a PhD in Theory of State and Political Comparative Institutions (2007) from *Sapienza* University, as well as an LL.M. in German and European Constitutional Law from *Humboldt* University in Berlin (hons., 2004). She was Research Fellow in Comparative Public Law at the University of Siena (2006-2010) and *visiting scholar* at Columbia Law School, New York (*Fall Term* 2014). She is qualified to practice the legal profession and is registered with the Rome Bar Association.

Prof. Di Martino teaches "Public Comparative Law" in the Degree of "Law and Public Administration" (12 CFU) and in the Master-Degree of "Law" (9 CFU) at *Sapienza* University, School of Law. She is member of the teaching body for the PhD course in Public Law. At the same University, she has taught "Public Law in the Light of European Experience" (9 CFU). She has also held from 2013 to 2016 a series of seminar lectures on "Landmark Decisions of the U.S. Supreme Court on Fundamental Rights and Freedoms" (in English); in 2014 and 2018 organized seminars on Comparative Constitutional Law and Literature. In 2013, she held a course on "Public Comparative and European Law" at the Department of Sociology of *Sapienza* University (6 credits) as well as a series of seminar lectures on "Landmark Decisions of the US Supreme Court on Fundamental Rights and Freedoms" (in English) at that University's School of Law. In the Department of Economics, she held a series of lectures on "The European Protection of Human Rights in Europe" (in English) as part of the Master's course in "State Management and Humanitarian Affairs" (2006). She also lectured on "Constitutionalism and Globalization" as well as "Privacy and Freedom of Information" at the University of Siena (2007-2008).

She was coordinator of University projects on "The Work of Konrad Hesse between Scholarship and Case-Law", "Constitutional Courts and Democracy in Comparative Law", and "Constitutional Adjudication and Preliminary Ruling from the Point of View of Cooperative Constitutionalism". She is now coordinator of a University project on "The Dimensions of Fundamental Rights". In addition, she has taken part in several national and international research projects. One of the most important was that on "Corruption in the Public Sector of the EU Member States," financed by the European Commission and coordinated by Düsseldorf University's *Istitut für Parteienforschung* (2006-2007).

Prof. Di Martino has taken part in national and international seminars and conferences. Among these, worthy of mention are the seminar of the Italian Association of Constitutional Lawyers on Public Law Scholarship during Fascism, in Florence (2017); the annual conference of the Gruppo di Pisa on Fundamental Rights at the University of Cassino (2016); the conference in honor of Peter Häberle, on "Human Dignity and Fundamental Rights in the Contemporary Constitutional State" at *Sapienza* University (2013); and the seminar on "German Roots of European Federalism" at the Italian-German Center of Villa Vigoni (2010).

She was member of the editorial board of the web Journal of the Association of Italian Constitutional Lawyers (2004-2009); she is now in the scientific board of the Journal "Rivista di Diritti Comparati" and in the board of direction of the Journal "Nomos. Le attualtà del diritto".
